### What are your rights as a data owner?

Pursuant to Article 11 of the Personal Data Protection Law, data owners,

- · Learning whether personal data is being processed,
- To request information about the processing of personal data if it has been processed, To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- Knowing the third parties to whom personal data is transferred, either domestically or abroad,
- To request correction of personal data in case it is processed incompletely or incorrectly, and

  To request that the transaction carried out within this scope be notified to third parties to whom personal data has been transferred,
- Although it is processed in accordance with the provisions of the Personal Data Protection Law and other relevant laws,
   Requesting the deletion or destruction of personal data if the reasons requiring it are eliminated
   and to request that the transaction carried out within this scope be notified to third parties to whom personal data has been transferred,
- By analyzing the processed data exclusively through automatic systems, the person himself/herself
  to object to the emergence of an unfavorable result,
- To compensate for the damage in case of damage due to unlawful processing of personal data.

You can apply for your rights listed above by filling out the Data Owner Application Form.

You can forward your request to our company. Depending on the nature of your request, we will process it as soon as possible and within thirty days at the latest.

Your applications will be finalized free of charge; however, the process may require additional costs.

In case of any such request, you will be charged a fee according to the tariff determined by the Personal Data Protection Board. can be done.
